Robinson et al.**, of 39 West Main Street, Alexandria, Ohio 43001 and filed by them with the Village Fiscal Officer on 2/6/2017, the Village of Alexandria Council will hold a **PUBLIC HEARING** on **Monday, April 17, 2017** at the **Northridge Primary School, 124 College Street, Alexandria, Ohio 43001** at **7:00 p.m.** to inquire into the validity of this Petition.*

At that **PUBLIC HEARING**, the Village of Alexandria Council and officials will continue to canvass the above Petition, consisting of 11 part petitions purporting to contain 147 signatures of electors of Alexandria obtained by the listed circulators and notarized by the listed notaries. There have been several irregularities noted in the Petition, to wit: misleading wording of the Petition itself, the legality of one or more circulators, the circulators' conduct and statements to the public in obtaining signatures on the petition, potentially forged and illegible signatures, and finally, questions about the legality of the notaries' acts. Since 2/6/2017, the Petition has been held at the Village Hall in the Fiscal Officer's custody at the above address for public inspection and canvassing and will continue to be held there until the **PUBLIC HEARING**. Members of the public may examine the Petition by going to the Village Hall during Village business hours and asking or by making an appointment by calling the above telephone number.

Any witness so testifying may be accompanied by counsel, whose participation shall be limited to the protection of the rights of the witness, and who may not examine or cross-examine witnesses. In addition to or lieu of attending, any member of the public may present his/her position, arguments and/or contentions in writing by mailing, delivering, faxing or e-mailing those communications to the Village Hall on or before April 17, 2017. All circulators and notaries are specifically invited, but not required, to attend this **PUBLIC HEARING**, which will be conducted according to the Constitution and laws of the State of Ohio, including Ohio Revised Code Title 7 and Title 35, plus the laws of and the Rules of Council of the Village of Alexandria, Ohio.
