


Parker Community Park Events Reservation Fee Schedule

Fee requirements to reserve a facility or grounds or both for an event that is wanted to be held at Parker Community Park in the Village of Alexandria, Ohio.

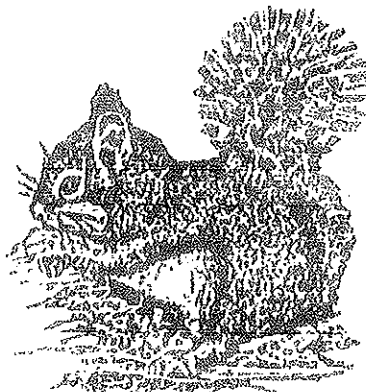
Upper Shelter House:	\$35.00

Sports Field for Adult Events:	\$45.00
Sports Field with One Shelter House:	\$50.00
(Excluding Electricity)(\$10.00 Extra for Electricity)	
Sports Field with Both Shelter Houses :	\$75.00
(Excluding Electricity)(\$10.00 Extra for Electricity)	
Entire Park with Electricity (Excluding Field Lights):	\$100.00
Sports Field Using Field Lights (Adult or Youth):	\$125.00
(For first four hours after lights are turned on: then an additional \$10.00 per hour for each hour or partial hour thereafter.)	

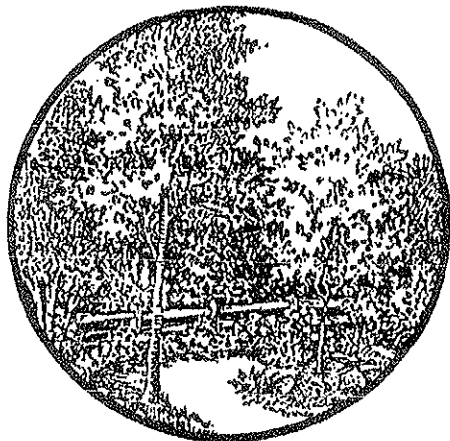

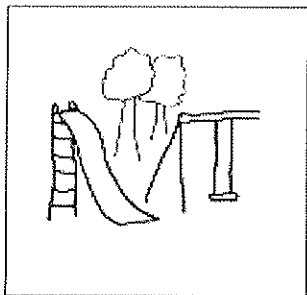

Park Rules

Park Hours: open from dawn to dusk unless confirmed by reservation

1. NO alcohol or drugs – state, local and federal laws all apply
2. NO firearms of any kind - state, local and federal laws all apply
3. NO unattended fires
4. NO dumping or littering
5. NO destruction of park property
6. NO unauthorized vehicles
7. NO profanity
8. Children must be accompanied by an adult
9. Pets must be on leash and all waste must be cleaned up
10. Confirmed reservations take precedence for all areas of park, including shelters, field or other park property
11. All trash must be cleaned up and placed in an appropriate trash receptacle and entire area must be left in its pre-activity condition (a cleaning charge may be applied if park is left littered and unclean)
12. If tables or other equipment are moved, they must be moved back to their original location
13. In case of emergency, please dial 911 or for non-emergency Licking County Sheriff at 740/670-5555

I have read the above rules and by signing below, agree to abide by them and acknowledge and understand that if we do not abide by the rules, we may be removed or barred from the park and/or fined or subject to further action by the Village of Alexandria.
