Newell Moved the adoption of the following Resolution:

WHEREAS, This Council in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2014; and

WHEREAS, The Budget Commission of Licking County, Ohio, has certified its action thereon to be levied by this Council, and what part thereof is without, and what part within, the ten mill limitation; therefore, be it

RESOLVED, By the Council of the Village of Alexandria, Licking County, Ohio, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further

RESOLVED, That there be and its hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation as follows: (*see Exhibits A and B*)

And be it further RESOLVED, That the Clerk of this Board be and he is hereby directed to certify a copy of this Resolution to the County Auditor of Said County.

THIS ORDINANCE IS DECLARED TO BE AN EMERGENCY MEASURE NECESSARY FOR THE HEALTH, SAFETY AND WELFARE OF THE CITIZENS OF ALEXANDRIA AND THE FURTHER REASON THAT COUNCIL NEEDS TO ACCEPT THESE AMOUNTS AND RATES AND RETURN SAID RESOLUTION TO THE LICKING COUNTY AUDITOR BY OCTOBER 1, 2013.


