RESOLUTION NO. R2018-5

**A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS
DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING
THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE
COUNTY AUDITOR**

WHEREAS, the Council of the Village of Alexandria in accordance with the provisions of law is required to adopt a Tax Budget for the next succeeding fiscal year commencing January 1, 2019; and

WHEREAS, the Budget Commission of Licking County, Ohio, has certified its action thereon to the Council for the Village of Alexandria together with an estimate by the Licking County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mill limitation, as reflected in "Schedule A and B" attached hereto; and

THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ALEXANDRIA, OHIO, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted;

AND BE IT FURTHER RESOLVED that:

Section 1: The Village Administrator/Clerk of Council is hereby authorized, on behalf of the Village of Alexandria, to file a copy of this Resolution together with the attached "Schedule A and B" with the Licking County Auditor.

Section 2: It is hereby levied on the tax duplicate of the Village of Alexandria the rate of each tax necessary to be levied within and without the ten mill limitation.

Section 3: This resolution shall take effect immediately upon passage.
